Telecommunications Subsidiary InfiniVAN's 10th Anniversary: Driving Digital Innovation with Japan-Quality Connectivity in the Philippines

We are pleased to announce that InfiniVAN, Inc. ("InfiniVAN"), our telecommunications subsidiary in the Philippines, celebrates its 10th anniversary on April 20, 2025. InfiniVAN will further contribute to the digital innovation of the Philippine social economy by providing high-quality telecommunications infrastructure of Japanese standards.

The Group's core Global Telecommunications Business began in 2012 by purchasing international telecommunications line capacity and selling it to cable TV operators offering internet services in the Philippines. In 2015, we established InfiniVAN and obtained a telecommunications license, allowing us to provide services in the Philippines using our own infrastructure. In 2020 and 2021, we acquired the right to use a portion of the international submarine cable City-to-city Cable System ("C2C Cable") connecting the Philippines to Hong Kong and Singapore, which will enable us to provide high capacity on international lines as well, and the Group became the third international data communication carrier in the Philippines, following two major telecommunications carriers.

With the completion of the Philippine Domestic Submarine Cable Network (PDSCN) in December 2023 and the establishment of a backbone network within the Philippines, it is now possible to fully deploy services throughout the Philippines, which were previously provided mainly in the Metro Manila area.
