Notice Concerning Business Acquisition by Consolidated Subsidiary

AUTOBACS SEVEN Co., Ltd. (the “Company”) hereby announces that its consolidated subsidiary, AUTOBACS Higashi-Nihon Sales Ltd. (hereinafter “AUTOBACS Higashi-Nihon Sales”), which operates as a franchisee, has resolved to acquire business operations of four AUTOBACS stores in Akita Prefecture from IA AUTOBACS Co., Ltd. (hereinafter “IA AUTOBACS”) and has signed a business transfer agreement today. IA AUTOBACS currently operates four AUTOBACS stores in Akita Prefecture, 10 AUTOBACS stores, and two Super AUTOBACS stores in Miyagi Prefecture. The details are described below.

1. Reason for the Business Acquisition

The AUTOBACS Group aims to expand profitability by implementing a variety of initiatives in accordance with the “2024 Medium-term Business Plan.” Through this business acquisition, we seek to optimize the operational structure of our store network in the Akita area, strengthen our regional competitiveness, and further enhance our overall earning capacity.

2. Overview of the Business Acquisition

AUTOBACS Higashi-Nihon Sales will acquire the business operations of four stores currently operated by IA AUTOBACS namely “AUTOBACS Odate Chuo,” “AUTOBACS Yokote Inter Store,” “AUTOBACS Akita Omagari Store,” and “AUTOBACS Akita Store,” effective July 1, 2025 (scheduled).
