

# Company Name Change from GFA to "abc Inc." and Relocation of Headquarters

As the brand that "Diversity, Tokenized", we aim to build a future value exchange system centered on Web3 technology

At the Board of Directors meeting held on May 30, 2025, we resolved to change our trade name to "abc Inc." effective September 1, 2025. This was approved at the 2 4th Annual General Meeting of Shareholders held on June 30, 2025. Today, September 1, we have officially implemented the company name change and relocated our headquarters to expand our business and improve operational efficiency.



When we imagine society from the present into the future, we believe that beyond d ivisions such as investors vs. workers, or prices vs. cash, people should be able to exchange value more freely. The convergence of "value" born in various spaces around the world, and the energy of those who wish to give that "value," creates communities, cultures, and diversity.

As a professional group specializing in currency and Web3 technology, we will be r eborn with the vision of "Tokenizing Diversity," expressed through words and cre ativity.

# 1. Company Name Change to "abc"

The new company name "abc" signifies the beginning of the alphabet and embodies our desire to be the "starting point" of diverse value exchange.

We aim to circulate values that cannot be exchanged within existing financial syst ems—such as goodwill, trust, cooperation, and support—through a new value exchange system.

#### New Mission: Diversity, Tokenized by abc

Business is, at its core, an exchange of value. And capitalism—meant to uph old a free and equal civil society—should support that. But even in the 21s t century, access to that value exchange isn't open to everyone.

The right to participate in places where value is traded-like the stock market—is still concentrated in the hands of capital holders. And in everyday exchanges, like buying a bag of rice, those who have neither products nor capital must offer up their own time and bodies on the labor market, converting their lives into money. But even that money—its value is decided somewhere far away, detached from the everyday present in front of us. This is roughly what our capitalism looks like.

Why can't we exchange? Our sensibilities are born here and now. Acts of go odwill offered to others, the kind of trust that moves a friend to action, the empathy that makes us want to share, the encouragement that comes without asking—none of these can be traded for a bowl of ramen or a single concert ticket. Not because they're worthless, but because they're not product s. Not capital.

abc is working to make these forms of value—those born in the "here, or the ere, or now"—exchangeable again, for the next hundred years to come. This "diversity" isn't just something to be celebrated. It's the origin of how human beings have always exchanged value.



The three letters "abc" both symbolize the starting point of value exchange and form an acronym for ai, blockchain, cryptocurrency. Each group business will be a ccompanied only by its wordmark, suggesting the process of diversity becoming curr ency through each business.

The background illustration of the logo reflects customs and landscapes of throwin g or washing coins in water to pray for wealth. In contrast to this scene, where o ne prays for increased value by washing "money," we propose that people already carry exchangeable value. By deliberately making this contrasting landscape the background of our logo, we embody both our awareness of the challenge-demonstrating "Tokenizing Diversity" precisely within such a world—and our commitment to innovation.

#### 6. Impact on Business Development and Future Strategy

Along with the name change, we have amended our Articles of Incorporation to add n ew business objectives such as "consulting services related to Web3 services and blockchain technology" and "investment, management, and research of crypto asset s."

Going forward, under the mission of "Tokenizing Diversity," we will promote the construction of new value exchange systems using Web3 technology, while accelerating a diversification strategy that includes traditional finance, real estate investment, and fund management, thereby establishing a foundation for sustainable growth.

In addition, to prepare for future business expansion, we will increase the total number of authorized shares from 37,000,000 to 100,000,000, enabling more flexible and agile capital policies.
